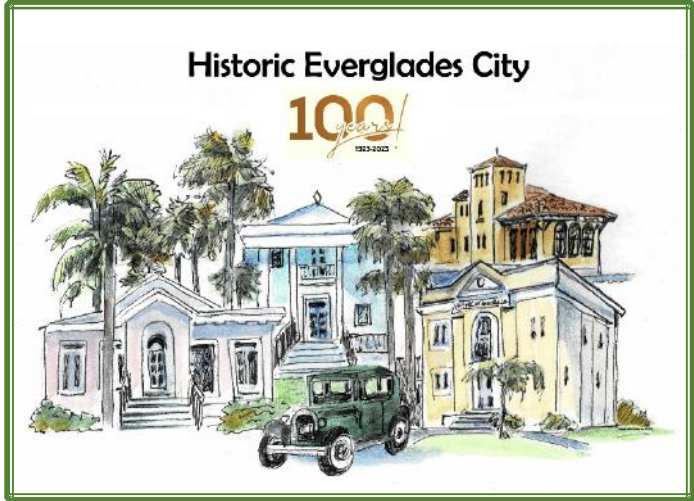

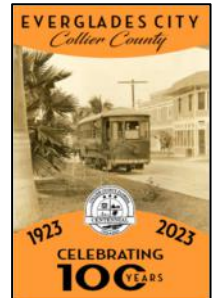
The artwork was generously donated by our new director Hannah Ineson. The tile measures 8x6 inches and can be used as a hotplate or just proudly displayed.

### BANK OF EVERGLADES BUILDING

#### *What's Been Happening?*

*The first quarter of 2023 has been very exciting for ESHP, including our Bank of Everglades Building Project.*

To summarize:

We started off the new year with the grant of \$3 million which was signed into the Federal Appropriations Bill on December 29, 2022, under the HUD program.

Our year-end appeal was very successful, and allows us to continue working on the Bank Building project while we wait for the federal funds.

Our Music Festival fundraiser, which was postponed due to Hurricane Ian, was a tremendous success despite the cold weather on January 14. Musicians donated their time and talents, a raffle was held as well as silent and live auctions (with donations from many businesses in town), all of which resulted in \$11,213.62 in net receipts. The Rod & Gun Club provided the perfect location.

ESHP is extremely grateful to MHK Architects in Naples for all their assistance this past year. As we move forward with federal funding, it is important to have the expertise of a firm recognized for its historic preservation work and knowledge of HUD grants. We are pleased to announce our association with Rick Gonzalez of REG Architects ([www.regarchitects.com](http://www.regarchitects.com)).

ESHP applied for state funding through the Division of Historic Resources and our grant application ranked 15 out of 36. The projects are now being discussed by the Florida House and Senate. The legislative session will adjourn on May 5, 2023, so we should know soon!! This was a matching grant; we requested \$53,000 so the total available amount will be \$106,000, half of which we must provide.
